Dear Adult Privilege Holder Applicant:

Thank you for your interest in the River Forest Tennis Club! We are so pleased that you would like to take advantage of the tennis and swim options at the Club and be a part of the Club family. The following form is required for consideration as a new Adult Privilege Holder for the 2018 season.

**In order for all member categories to be reviewed and included in the 2018 RFTC Directory, completed applications are due by Monday, April 23th.** Applications received after that date will be reviewed subject to capacity.

Please return the enclosed application form with the necessary signatures along with your check payable to the River Forest Tennis Club. **This year's membership fee is \$800.00.** Use of the locker rooms is included in your fee but locker rental is not. If available, full-size lockers can be rented for \$30.00. Please include a separate check if you wish to rent a locker; your locker rental check will be returned if a locker is unavailable.

Applications should be returned to **Kirstin Wells, 823 Franklin Avenue, River Forest, IL 60305**. Submittal of this application is not a guarantee of membership. Following review and approval by the RFTC Board of Directors, you will be notified in late April as to the status of your application. Membership directories and sign up information for tennis programs will be available later in May for pick up at the Club office.

Adult Privilege Holders are governed by the same club rules and regulations as other members, with two noteworthy exceptions: Privilege Holders may not invite guests to the Club and only one adult member per family can be an Adult Privilege Holder.

The complete Club rules and regulations are detailed in the Club Directory. There are no court fees nor are there limits on the number of times you may use the tennis courts, except as limited by the sign-up procedure used during periods of high demand. The sign-up register is located outside the Pro Shop.

The Club observes the "all white" dress rule for tennis attire.

Pool hours will be published in this year's Club Directory. Swimmers must sign in at the pool house. All swimmers must wear "cover ups" over their swimsuits when leaving the pool area and entering the Club grounds.
