Please review these brief tennis and pool rules:

- Play and behavior of Youth Privilege Holders will be supervised by the Club Managers and the Tennis and Pool staff.
- Youth Privilege Holders may use the courts Monday through Friday until 4:30 p.m., but not on weekends, holidays, and special Club event days.
- Attire on the tennis courts must comply with the Club's all-white rule.
- Youth Privilege Holders must follow the same rules for court sign-up and usage as Club members, except as noted above.
- Pool hours will be outlined in the Club Directory.
- All swimmers must "check-in" at the pool house when entering the pool area.
- Outside the pool area, swimmers must wear footwear and a swimsuit "cover-up."
- Running is strictly prohibited within the pool area, but allowed on the lawn.
- Sun bathing is permitted only within the pool area, but not on the lawn.
- The Pool Director and lifeguards have full authority to enforce pool rules.
- Youth Privilege Holders may not invite guests to the Club.

If you have any questions about Club rules, please talk to the Club Managers or a member of the Pool or Tennis staff.
