Dear Youth Privilege Holder Applicant:

Thank you for your interest in becoming a Youth Privilege Holder (YPH) this summer at the River Forest Tennis Club. Enclosed is the application for your completion and submission **by April 1, 2023**. **Please note that spots are limited.**

Youth Privilege Holder applicants must have completed the 4th grade by the summer they are applying for membership, or are at least 10 years of age on September 1st of the year prior to the application but less than 18 years of age by April 1st of the year of application, or are a full-time high school student regardless of age.

The fee for a Youth Privilege Holder is \$775 for the full season. This fee is non-refundable after the club opens to Youth Privilege Holders. For details on YPH inclusions, please see <https://rftc.org/Membership>.

In 2023, Youth Privilege Holders can sign up for swim team and/or water polo for a separate fee. Please return the following three items:

- Application Form completed and signed
- Sponsor Statement and Signature Form
- Wallet size photo of applicant (with name on back of photo)

After the application due date of April 1st, applicants will be notified and payment will be due immediately. Payment must be made in full before membership is approved. *NEW* for 2023 - payment options by check OR Zelle to RFTCpayments@rftc.org (not case sensitive). Please note YPH in the memo of your Zelle transaction.

Submission of this application is not a guarantee of membership. Following application review by the RFTC Board of Directors, you will be notified as to the status of your application. Sign-up information for swim team and water polo as well as the Club's other swim and tennis programs will be sent out via email and more information will be available at the Youth Privilege Holder Meeting (timing TBD). A detailed letter of acceptance will have information about these important dates and times.

Please note: RFTC will not approve any new applications for a Youth Privilege Holder and an Adult Privilege Holder(s) in the same immediate family except by direct Board action.

Please review these brief tennis and pool rules:

- Play and behavior of Youth Privilege Holders will be supervised by the Club Managers and the Tennis and Pool staff.
- Youth Privilege Holders may use the tennis courts Monday through Friday until 4:30 p.m., but not on weekends, holidays, and special Club event days.
- Attire on the tennis courts must comply with the Club's all-white rule.
- Youth Privilege Holders must follow the same rules for court sign-up and usage as Club members, except as noted above.
- Pool hours will be sent out via email.
- All swimmers must "check-in" at the pool house when entering the pool area.
- Outside the pool area, swimmers must wear footwear and a swimsuit "cover-up."
- Running is strictly prohibited within the pool area, but allowed on the lawn.
- Sun bathing is permitted only within the pool area, but not on the lawn.
- The Pool Director and lifeguards have full authority to enforce pool rules.
- Youth Privilege Holders may not invite guests to the Club.
- Privilege Holders are not allowed to have a house account to charge items, food, or services. These items must be paid for at the time of service in the RFTC office using cash or a credit card, or with cash at the Court 6 Café.

If you have any questions about Club rules, please talk to the Club Manager or a member of the Pool or Tennis staff.

We are looking forward to a great summer of tennis and swimming at the RFTC. We hope you will be joining us for the 2023 season, and thank you for your youth privilege holder membership! Please contact us with any questions.

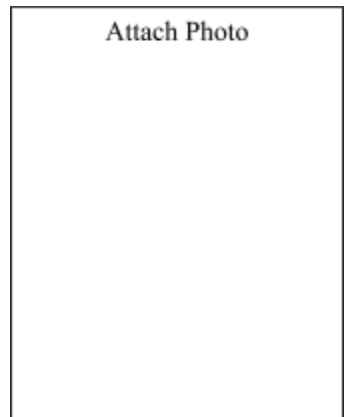
